1. The Chairman MPC on behalf of the Ministry of Women & Child Affairs and Dry Zone Development now invites sealed bids from eligible and qualified bidders for supply of **eighteen (18) RO Plants** for Dry Zone Development Project.
2. Bidding will be conducted through **National Competitive Bidding**.
3. Interested eligible bidders may obtain further information from Assistant Secretary (Administration), Ministry of Women & Child Affairs and Dry Zone Development (Contact No. 0112187246) and inspect the Bidding Documents free of charge at the address given below from 09:30 hours to 15:00 hours on any working day starting from 11<sup>th</sup> June 2019 to 24<sup>th</sup> June 2019.
4. To be eligible for contract award the successful bidder shall not have been blacklisted and should have minimum 3 years experience in the field of design, supply, fixing and maintenance of RO Plants, at the time of the submission of bid. Additional details are provided in the Bidding Documents.
5. Bidding Documents will be issued only to those who are manufacturers or their local accredited agents for supply and delivery of RO Plants upon production of a letter of request for documents on a business letter head together with the Certificate of Registration of the Contract as per the Act No. 3 of 1987 with the Registrar of Public Contract.
6. A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of non refundable fee of Rs.8000/= to the Shroff, Accounts Division, of the address given below. The method of payment will be cash only.
7. The Bidding Documents are not transferable.
8. Bids must be placed in the bid box kept in the office of Additional Secretary (Administration) of the ministry or send through registered post to the address below,

before 2.00 p.m. on 25<sup>th</sup> June 2019. Please indicate as “**Procurement of RO Plants**” on the top left hand corner of envelop. **Late bids will be rejected.**

9. All bids must be accompanied by a bid security of Rs. 675,000/= which is valid at least 91 days.
10. Bids will be opened immediately after closing in the presence of the bidders or their representatives who choose to attend in person at the address below at 2.00 p.m. on 25<sup>th</sup> June 2019.
