
First meeting of the Internal Affairs Unit held on 2025.04.04



Informing all heads of institutions not to take any action against the person or institution who reports a bribery or corruption allegation in writing/telephone/email or in any other manner, and to refer any false allegation or complaint to the Internal Affairs Unit (IAU) without delay if it is made with the intention of causing personal prejudice and injustice
