01. Calling EOI for hiring a Consultant on Individual Basis (01 Position)

The Chairman Ministry Consultancy Procurement Committee (CPCM) on behalf of the Secretary, Ministry of Women and Child Affairs invites sealed EOIs from eligible and qualified Consultants, for formative evaluation of Livelihood Development Programs (LDPs) under Asian Development Bank's Food Security and Livelihood Recovery Emergency Assistance Project (FSLREAP). The evaluation aims to assess the LDP's relevance, effectiveness, efficiency, challenges and emerging outcomes, while providing recommendations to inform future implementation and policy directions.
